

Terms and conditions of use of www.woseba.pl

P.P.U.H. WOSEBA Sp. z o.o. in Odolanów

General provisions

The owner of the website is P.P.U.H. WOSEBA Sp. z o.o. seated in Odolanów, Krotoszyńska 150, 63-430 Odolanów, National Court Register no. /KRS/ 0000013901 (further referred to as Company, WOSEBA Company or administrator).

The website is managed by betterandmore sp. z o.o. seated in Poznań, Gronowa 22/1210, 61-655 Poznań, National Court Register no. /KRS/ 0000634226.

Users who do not agree to comply with provisions of this document are kindly asked not to use the website. Other websites of the Company may be subject to different terms and conditions, which need to be read separately.

Intellectual property rights

Any intellectual property rights, including in particular copyrights and rights to trademarks related to any texts, pictures, sounds, software and other materials included in this website constitute the property of WOSEBA Company or its affiliated entities, and they may only be used after obtaining a consent to use them from respective owners.

Personal data protection

In pursuance with the obligation specified in Art. 13 and 14 Regulation (EU) 2016/679 of the European Parliament and of the Council regulation of 27 April 2016 on the protection of natural persons with regard to processing personal data and on the free movement of such data, and repealing Directive 95/46/EC (further referred to as GDPR), as well as obligations provided for by other legal acts, including in particular the Personal Data Protection Act of 10 May 2018 (Journal of Laws 2018, item 1000), the following information is being disclosed:

- users have the right to review the documentation; they also have the right to request amending, deleting or limiting the extent to which their data is processed should they deem processing to be inappropriate; to perform any of the above-quoted procedures, please contact the Company at sekretariat@woseba.pl,

- data is processed under Art. 6 item 1 c, f GDPR.

Users who claim that their personal data is being processed inappropriately, may file appeals to the President of Data Protection Agency seated in Warsaw.

Complaint handling procedure

The Company provides users with the possibility of filing complaints concerning contact details of the entity managing the website, i.e. contact details of betterandmore sp. z o.o. seated in Poznań, given below in the Terms and Conditions, especially in the following case:

- if user's rights under legally binding regulations or the Terms and Conditions have been violated.

Users may also file complaints to the Company if any other incidents occur.

Complaints are to be forwarded to the contact address of P.P.U.H. WOSEBA Sp. z o.o. seated in Odolanów, which will allow the Company to monitor the correctness and time of handling complaint procedure by the entity managing the website, i.e. betterandmore sp. z o.o. company seated in Poznań.
