

In accordance with Article 13(1) and (2) of the General Data Protection Regulation of 27 April 2016 (GDPR), I would like to inform you that:

1. The Administrator of your personal data is P.P.U.H. Woseba Sp. z o.o. with its registered office in Odolanów, 150 Krotoszyńska Street (VAT ID: 6220006580).

3. Your personal data will be processed for the following purposes:

A. sales transactions on the basis of a contract, an order, a sales service, based on the legal basis of Article 6(1)(b) GDPR,

B. issuing financial and accounting documents confirming sales transactions based on the legal basis of Article 6(1)(c) GDPR,

C. assertion of claims based on the legal basis of Article 6(1)(f) GDPR,

D. marketing purposes based on the legal interest of the Administrator based on Article 6(1)(f) GDPR,

E. statistical and analytical research into sales potential based on the legal basis of Article 6(1)(a) and (f) GDPR, , by means of automated profiling of your person consisting in the collation, from various sources, of information on the volume (including the value and quantity and details of transactions) of your sales of the Administrator's goods and on your sales of the goods of the Administrator's competitors in order to build your profile, which will be used by the Administrator to offer you dedicated commercial offers for the purchase of the Administrator's goods. For information on profiling see para. 10

F. processing of complaints on the basis of Article 6(1)(b) and (c) GDPR.

4. Your personal data will be forwarded to tax offices, banks, carriers, Poczta Polska S.A., courier companies, law firms, the National Revenue Administration, customs offices, translators, auditors, auditing companies, companies providing sales, order and invoice processing services through software, electronic platforms, companies providing sales and marketing services, suppliers of IT solutions.

5. Your personal data will not be transferred to countries outside the European Union.

6. Your personal data will be processed:

Purpose A. For the period for which records are kept, as defined by generally applicable law, but for no less than the time necessary for the protection against or execution of claims.

Purpose B. For the period for which records are kept, as defined by generally applicable law, but for no less than the time necessary for the protection against or execution of claims. Purpose C. Until the statute of limitations for claims expires.

Purpose D. Until the business relationship ends.

Purpose E. Until the business relationship is terminated

Purpose F. Until the end of the complaint procedure and in accordance with the Accounting Act.

7. You have the right of access to the content of your data and the right to rectification, erasure, restriction of processing, the right to transfer the data and to file objections (applies to Purposes C-F). In addition, you have the right to withdraw your consent to the processing of your data at any time which does not affect the lawfulness of the processing carried out on the basis of your consent prior to its withdrawal.

8. You have the right to lodge a complaint with the President of the Data Protection Authority if you consider that the processing of your personal data violates the law.

9. Despite profiling, no automated decisions will be taken in relation to you as referred to in Article 22(1) and (4) of the GDPR.

10. The profiling referred to in para. 3(E) is intended to build a picture of the size of your sales of the goods of the Administrator and its competitors.

The importance of profiling focuses on increasing the size of your purchases of the Administrator's goods by offering you terms and conditions for the purchase of the Administrator's goods that are tailored to the size of your current sales.

The foreseeable consequence of this profiling for you by the Administrator will be:

- A. obtaining information by the Administrator about the extent of your sales of the goods of the Administrator and its competitors and including the share of the Administrator's goods in all your sales;
- B. offering you, on the basis of the information in point. 1), commercial offers for the purchase of the Administrator's goods tailored to your sales;
